July meeting minutes were approved by Brett Fulton and seconded by Tracey Velekei

Seegers Expansion/Renovation Presentation (Rick Waligora & Jane Schubert):

- There will be over 35,000 ft. of expansion to Seegers.
- Prosser Lot will be closed to parking and will only be used for storm water drainage and construction parking.
- Footings and foundations are projected to begin late December/Early 2025.
- Steel installation is projected to begin Spring '25 and to be finished during Summer.
- The construction manager will hold weekly safety meetings. If anyone notices any issues/concerns, please contact Rick directly.
- Will work with Sodexo to accommodate delivery traffic.
- Goal is for the outside to be complete by July 2025.
- The Office of Communications and Marketing will be providing signage with plans, timelines, etc. throughout the project.
- The Event Space will remain open during the renovation. A partition will be installed to block out the construction area.
- GQ Annex will be completely closed off.
- The Light Lounge, 108-110 is scheduled to be refreshed over Spring Break '25
- Java Joe's, Lounge, Lobby, GQ is scheduled to be refreshed beginning May 19 thru Summer
- A softball field will be added next to Scotty Wood Stadium and Bicentennial Park will be renovated with a goal of completion by 4/1.
- Renovation/Refresh Impacts:
 - 8/1 - 5/2026 Construction Fencing & Prosser Lot closure.
 - 8/5 - 11/1 Utility Relocations will occur (mostly over Fall Break during which food will be served in Moyer.

Accidents & Injuries:

- Employee fall on 3rd floor of Haas - now closed.
- 1 new injury - Employee injured fingernail while adjusting hdmi cord on projector. Not confirmed at time of meeting if the individual went to St. Luke's. Awaiting additional info.
